**Certificate Rates**

Certificate rates are subject to change at any time. All other rates are subject to change monthly. Dividends are paid on all open accounts. APY is based on withdrawn dividends, if dividends remain on deposit until maturity APY may be higher. A withdrawal from the Certificate will reduce earnings. Dividends are compounded daily and credited monthly on all Certificates and IRA Certificate accounts. A penalty may be imposed for early withdrawal.
